

Wilmot Mountain Flea Market, Inc. Merchandise Vendor Rules and Regulations Form

- 1. Wilmot Mountain Flea Market, Inc. © reserves the right to refuse admission to any vendor. Vendors may not sublease any part of their selling space.
- 2. Sale of any item prohibited by any city, town, county, state, or federal law is prohibited. No fireworks, guns, ammunition, consumable food or beverages, pornography, CBD products, drug related products, or used mattresses and bedding or otherwise flammable or dangerous items allowed on the property. Wilmot Mountain Flea Market, Inc. © reserves the right to determine whether any item or items are dangerous.
- 3. In the event of rain, rain checks will not be issued. It has been our experience that vendors who stay and wait for the rain to stop do very well. We strongly suggest that vendors endure inclement weather.
- 4. Wilmot Mountain Flea Market, Inc. © is a "family market", therefore absolutely no pornographic or "X" rated material such as films, magazines, DVD's, etc. are allowed to be sold.
- 5. The sale of counterfeit merchandise, or merchandise which violates trademarks and copyrights of others is prohibited. It is the obligations of the seller to verify that the merchandise offered for sale is not counterfeit. By accepting these rules, seller indemnifies Wilmot Mountain Flea Market, Inc. © Wilmot Mountain, Inc., and the Town of Randall Wisconsin from any action taken against seller if merchandise is found to be counterfeit.
- 6. No selling outside of vendors rented space is allowed. All aisles must be kept clear of vehicles and merchandise.
- 7. Portable canopies must have a minimum of 50 lbs. weight on each vertical pole for wind control.
- 8. Wilmot Mountain Flea Market, Inc. © will not accept checks or cards as payment, cash only.
- 9. Absolutely no animals allowed on the premises other than licensed service dogs. Wilmot Mountain Flea Market, Inc is not responsible and cannot be held liable for any incidents occurring, as a result of vendors or customers not complying with this policy.
- 10. No political material may be distributed. No walking sales are permitted. No loudspeakers, bullhorns, excessive music, or excessive shouting is allowed. Sound on all radios must be kept to a level which does not bother neighbors.
- 11. Vendors must conduct themselves in an acceptable and orderly manner. Wilmot Mountain Flea Market, Inc. © reserves the right to determine what behavior is disorderly or unacceptable.
- 12. Kenosha County Law Enforcement will enforce all local ordinances, laws, and regulations.

- 13. YOUR SELLING AREA MUST BE KEPT CLEAN. Please respect this open space. You are responsible for taking your unsold merchandise. Any violators will be charged \$50.00 for excessive clean up expenses. We will mark down license numbers so as to contact vendors who leave excess garbage. Vendors agree to a cleanup charge and the possibility of not being allowed to sell at Wilmot Mountain Flea Market, Inc. YOU MUST TAKE YOUR GARBAGE WITH YOU BEFORE YOU LEAVE. The land is privately owned and as such requires us to comply with the owners' rules, in addition meeting environment needs, and to maintain low costs. Please do your share, and do not ruin the unique opportunity we have to provide a place in which to sell your goods.
- 14. Vendors agree to indemnify, and to hold harmless Wilmot Mountain Flea Market, Inc. ©, Kenosha County Fairgrounds, and the Town of Randall harmless from any and all claims (including the cost of defense of any claim) resulting from vendors activities on the Wilmot Mountain Flea Market, Inc. ©, / Kenosha County Fairgrounds property. Vendors shall adequately supervise and control the activities of their employees, agents, helpers, and will be responsible for the activities of those individuals. These rules will be the receipt confirmation that each vendor will agree to upon entry to the market.
